Offices at Grand Bay Plaza, 2665 South Bayshore Drive, PH-2B, Miami, Florida 33133 in the amount of the total balance of all the following BOA accounts:
 - a. Account No. 0184 (Titled: One Rodeo LLC);
 - b. Account No. 0197 (Titled: One Rodeo LLC);
 - c. Account No. 4193 (Titled: Odette Hitti MA Antonieta Guraieb);
 - d. Account No. 5028 (Titled: Odette Hitti, P.A.); and
 - e. Account No. 5031 (Titled: Odette Hitti, P.A.) (all five accounts collectively, the “BOA Accounts”).
3. Upon payment of the full balance of the BOA Accounts to the Receiver by transmission of the check referenced in paragraph 2, BOA shall close the BOA Accounts.
4. BOA shall not have liability to any party or third party for transferring the funds from the BOA Accounts to the Receiver in compliance with this Order.
