**ORDER GRANTING MOTION TO CONVERT REMAINING DORMANT ASSETS INTO
A FORM OF TRUSTEESHIP**

THIS CAUSE having come before the Court on the Motion to Convert Remaining Dormant Assets into a Form of Trusteeship (the “Motion”) filed by Scott M. Dimond (the “Receiver”), as Receiver of Daily Bread, LLC, pursuant to the Court’s December 14, 2021 Order Granting Plaintiffs’ Emergency Motion for Appointment of Receiver (the “Appointment Order”), and the Court having considered the Motion, heard the argument of counsel on March 5, 2026, and all relevant factors, it is hereby

ORDERED AND ADJUDGED that:

1. The Motion is **GRANTED**.
2. This Court approves the establishment of the Daily Bread Remediation Trust (the “Trust”) as the successor to the Receiver and receivership formed pursuant to the Court’s December 14, 2021 Order Granting Plaintiffs’ Emergency Motion for Appointment of Receiver (the “Receivership”) for purposes of holding, managing, and distributing the Receivership’s remaining assets.

3. This Court authorizes the transfer of all remaining Receivership assets into the Trust, including but not limited to the Receivership's interests in Pink Chit, LLC and Turnerfield Holdings, LLC, along with all rights and entitlements under the Kirkwood Settlement Agreement.


4. This Court confirms that the Trustee of the Trust shall succeed to the Receiver's rights and responsibilities under the Kirkwood Settlement Agreement, including the right to receive distributions from Pink Chit, LLC and Turnerfield Holdings, LLC, enforce obligations against Mr. Kirkwood, and maintain any liens securing payment obligations.

5. This Court confirms the appointment of Scott M. Dimond as the initial Trustee, with all powers necessary to carry out the administration of the Trust.

6. Following the establishment of the Trust and the Receiver's taking such steps necessary to transfer the Receivership's remaining assets to the Trust while planning for the disposition of all remaining financial obligations of the Receivership, the Receiver shall seek the discharge of the Receivership.

7. Within 30 days from the date of this order, the Receiver shall complete the transfer and upload a proposed order closing the receivership and discharging the receiver in accordance with the Receiver's motion and proposed plan.
